Strumpshaw Parish Council Minutes

Parish Council Meeting held Tuesday 7 March 2023 at 7:30 p.m. at Strumpshaw Community Hall, Mill Road, Strumpshaw, NR13 4FS.

Present: Sheila Ashford (Chairman), Michael Green, Martin Kentish, Paul Kitley and Tina McAulay.

In attendance: Tanya Rowlandson (Clerk), District Councillors Jan Davis and Eleanor Laming, Sarah Cartwright (CHC Chairman), Alasdair Fraser (Tree Warden), Hilary Hammond (BWPC Chairman) and one member of the public

- 1. Apologies for absence were received from Martin (Olly) Page and County Councillor Andrew Proctor.
- 2. There were no declarations of interest in items on the agenda.
- 3. The minutes of the meeting held 17 January 2023 were approved and signed.
- 4. Suspend standing orders for public participation and receipt of reports from County and District Councillors

A copy of the report submitted by District Councillors Davis and Laming is filed with these minutes. County Councillor Andrew Proctor did not submit a report with his apologies.

The member of public advised that the footpath from Barn Hill to Stone Road has been ploughed up. It was resolved that the Clerk would contact the tenant and request reinstatement of the footpath when the field is drilled.

5. The Community Hall Committee operational update was noted, and it was unanimously resolved to allow sleepovers to be run in accordance with the attached policy and special condition of hire.

Proposer: Paul Kitley Seconder: Tina McAulay.

6. Buckenham Wood Project Committee update

HH advised the meeting that The Norwich Fringe Project have been booked in for 9, 15, 16, 22 and 23 March 2023, to undertake the following works: finish the entrance gate, install a French drain, level off and install up to 8 additional steps, additional section of 15metres path, a new bench and hard standing.

Once completed, there will be approximately £2500 left in the green infrastructure fund for the BWPC to consider utilising.

7. The Tree Warden's tree safety inspection and risk assessment for Buckenham Wood were noted. Council was reminded that regular inspections of structures within the wood (steps, benches, gates) and removal of any dangerous rope swings must be carried out, to ensure safety of users.

The Chairman thanked AF for carrying out the tree safety inspection and risk assessment.

8. Adoption of the Local Government Association Model Councillor Code of Conduct 2020.

Proposer: Michael Green, Seconder: Tina McAulay. It was unanimously resolved that Strumpshaw Parish Council adopt the LGA Model Councillor Code of Conduct 2020 for the newly formed Council in May.

The Monitoring Officer at Broadland District Council will provide a new Parish Council Register of Interest form for those councillors elected on 4 May 2023 to complete and submit.

9. Dog poo bins update

The Clerk made a request to Lingwood and Burlingham Parish Council for an additional bin at Buckenham Road, Lingwood where the footpath leads to northern edge of Buckenham Woods. LBPC resolved not to purchase an extra dog bin but would keep it under review.

MK advised ongoing discussions with BDC, slow progress following the Contracts Officer's recent email response dated 22 February:

"After looking into the new proposed location a little further, it would seem that the entrance to the closed landfill site is not a public right of way. The landfill site here is managed by Norfolk County Council so they would need to pay for a bin to be installed and emptied in this location. We would not look to relocate our bin to here.

The footpath on the other side of the road to this entrance is a public footpath, so we could look at relocating the bin here. However, this will need to be approved by Norfolk County Council Highways. If you are able to identify a potential suitable location on this footpath for the bin, please mark it on a map for me. I will then provide this, along with a request to install a bin here to Norfolk County Council highways".

The Chairman asked our District Councillors if they would be able to intervene/assist on our behalf.

10. SAM2 update

MK advised that February 20,000 vehicle recorded with the average speed at 27.2 mph, 28% speeding at 33 mph and 100 cars were recorded speeding in excess of 40 mph.

It was evident that the SAM2 is a benefit to the community, and it was noted that when the pub is busy and cars are parked on the side of the road, this also slows the traffic.

Council may wish to consider additional speed prevention measures such as requesting chicanes, speed tables and additional roundels or carriageway roundels.

The Clerk is to further chase NCC Highways Engineer for an update on the 30mp speed roundels, sunken road at junction of Mill Road and Norwich Road and the completion of footpath on north side of Norwich Road.

11. 11.1. To consider the response to County Deal for Norfolk public consultation

The Council resolved not to submit a response, as it was felt there was insufficient information available to make an informed view.

11.2. To consider the response for the consultation on Greater Norwich Local Plan (GNLP) Gypsy and Traveller Sites Focused Consultation

It was resolved that PK would draft the Council's response for the clerk to submit with the grounds for objection being location and proximity to the A47, overcrowding, visual impairment, road safety and hazards to children and pets, pollution and waste, amenities, noise, flood risk, commitment to enforcing the plan.

A copy of the objection letter submitted by email is filed with these minutes.

It was unanimously resolved to accept the finance reports and approve the payments and income received.

MG and TM signed the reports at the end of the meeting.

13. Planning application: 2023/0217 - 3 The Green, Hassingham, NR13 4HQ

Proposal: single storey timber frame wrap around extension, demolition of conservatory and replacement of porch.

It was resolved to recommend approval of this application, subject to no neighbour objections.

The Clerk advised of the Broads Authority notification for consultation on application reference BA/2023/0083/FUL, repair of the existing drainage channel and extension to outflow pipe for the Pumping Station, Low Road, Strumpshaw, Norwich and requested email responses are submitted by 21 March.

14. Buckenham Wood Trust update - Public Session (Michael Green and Paul Kitley)

14.1. To receive the Buckenham Wood survey No.2 results

PK presented a PowerPoint Buckenham Woods - an opportunity for Strumpshaw and neighbouring parishes survey 2 - values, uses, expectations, (a copy is filed with these minutes).

Key Points:

- 60% overall voted for Buckenham Wood Trust as the name.
- 55% of those who voted and showed an interest in becoming a member, either saying 'yes' or 'maybe' also voted for Buckenham Wood Trust and their preferred name of the Trust.
- There is a clear preference from the public for Buckenham Wood Trust to be the name.
- Question 9 "Should sufficient funds be raised by all parties for the long-term care of the wood(s) and their enjoyment by the public?" 65.62% (from 224 responses) responded Yes.

14.2. To note the outcome of the meeting with landowner

SA and MG advised that a meeting had taken place with the landowner to

discuss enabling a charitable trust to be established, which would raise the funds to cover the purchase price, legal costs, public liability insurance and ongoing maintenance costs of the woodland. The purchase price and sale of the land would be reliant upon a satisfactory land contamination survey being carried out.

MG advised that the trust constitution is under draft and would require 7 trustees, it is proposed that 2 of these trustees would be appointed by parish councils (1 to be appointed by Strumpshaw Parish Council and 1 to be appointed by Lingwood and Burlingham Parish Council).

Sheila Ashford proposed that Michael Green should be the SPC appointed trustee, this

was seconded by Paul Kitley. It was noted that Lingwood and Burlingham Parish Council would be appointing their trustee shortly.

SA thanked PK, MG and HH for their time and efforts in getting this project moving forward and advised the meeting that it is no longer a parish council matter, as it will be for the two parish council appointed trustees to appoint the remaining trustees; enabling the trust to be established and raise the funds to purchase the 7.4 acres of ancient woodland and cover the ongoing maintenance costs.

14.3. It was resolved to exclude the public and press for item 16 because their presence would be prejudicial to the public interest due to confidential nature, in accordance with the Public Bodies (admissions to meetings) Act 1960 s1(2) - commercially sensitive information.

The public meeting closed at 8:37 p.m.
