## 1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). ## 2 External auditor's limited assurance opinion 2022/23

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Section 2, Boxes 7 & 8 for the prior year has been restated, however as a result Section 2, Box 7 for the prior year does not agree to Boxes 1+2+3-(4+5+6). The smaller authority should have also restated either Box 3 or Box 6 to reflect the adjustment to Boxes 7 & 8.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR. Information received from the smaller authority indicates that assets purchased during the year have not been included in Section 2, Box 9.
